## <u>A Colbert County Platform for Judicial</u> and Law Enforcement Offices

As we approach the time for candidate qualifications, which will occur early in 2022, I urge our committee members and all voters to consider our expectations of candidates we'd like to see elected. We will elect a district judge, district attorney, and sheriff next year, and I believe it is important to enter into the qualification season with a strong platform of principles by which we'll communicate our expectations of any officeholder.

I have begun to assemble a list of items that I would like to see candidates support. In the coming months I would like to hear input from members and others about possible additions and refinements to this list.

First, I would like to see candidates support a public posting of the case processing times for our local courts. Voters should know how long the process takes to bring cases in our courts and to have them properly adjudicated. For proper consideration, statistics for cases in our county should be compared to other counties with similar populations.

I would like to see our judiciary races eventually opened to candidates from outside the county/circuit/district in which they intend to serve. The reason for this is simple. Under the current system, a candidate for judge may only be chosen from the barcertified lawyers who live in the county served by the court where he/she wants to be the judge. Since most lawyers appear in

courts serving the county where they live, this means that unless a sitting judge chooses to retire or dies in office, a lawyer seeking to run against him/her is choosing to run against the judge in whose court they must appear and bring cases daily.

Of course, this is an impossible situation, and it is the reason that incumbent judges almost NEVER have opposition in elections. This is not a situation that serves voters who deserve to have a choice in judicial elections. Allowing lawyers to run for election in counties outside of their home-county, like we already do with school superintendent candidates, would help bring more choices to voters for the critical roles of circuit and district judges.

Statistics for local crime rates, including their frequency and trending data, should be posted on the local county website. While some of this information can be found on other sites like the FBI, we deserve to see how our county law enforcement and judicial system is serving us in terms of crime reduction and safety in a convenient and easily referenced place. Such a resource should show how crime is either increasing or decreasing and compare these rates to other counties with similar populations.

In addition to these ideas, I would also like to have a discussion about specific items we want to see candidates support like programs to reduce domestic abuse and illegal drug use. Having this discussion and developing a consensus among Republican voters around our expectations will certainly make a positive step in improving how law enforcement and our courts serve our community.

### **ALGOP 2021 Winter Meeting**

The Alabama Republican Party held its 2021 Winter Meeting on Saturday, February 27, 2021 at the Renaissance Montgomery Hotel. Elections were held for officers to serve on the ALGOP Steering committee. Mr. John Wahl of Limestone County was elected to replace Terry Lathan as chairman of the state Party. John Skipper of Mobile County was elected as senior vice chairman. Lauderdale County chairman and ALGOP secretary Josh Dodd was elected vice chairman representing congressional districts 4 and 5. Carol Jahns from Autauga County was elected secretary, and Sallie Bryant from Jefferson County was unopposed in her run to remain the ALGOP treasurer.

The Committee passed twelve resolutions which I have listed in the next section. An amendment to the standing rules regarding "Denying Ballot Access" was listed on the agenda and had been submitted by Mr. Matthew Hitt of Madison County. The

proposed additional reason for denying a candidate access to the Republican ballot read as follows:

Republican office holder willfully engages in conduct that disregards the principles of the Alabama Republican Party, the Platform of the Alabama Republican Party or a resolution properly passed by this Committee.

Before this amendment could be introduced, a member made the motion to adjourn the meeting. Since under regular rules of order such a motion may not be debated, a vote was taken and the meeting was adjourned without taking up the issue of the amendment. I make note of it here to bring members attention to this effort to establish accountability for elected Republicans who seem to disregard the stated goals of the Republican Party. I was concerned about the language and the possibility that such a rule could be misused, but I applaud the sentiment behind it.

## **State Party Resolutions from the 2021 ALGOP Winter Meeting**

The Committee passed more resolutions during this meeting than anytime before in my recollection. I have included a list below of the titles and "resolved paragraphs" from all twelve resolutions brought to the floor. I have included my own commentary, which appears in plain font. Text copied from the resolutions appears in italics.

### Resolutions passed:

NOW THEREFORE, BE IT RESOLVED, that the Alabama Republican Executive Committee urges support for Congressman Rogers' H.R. 204, the American Sovereignty Restoration Act; and BE IT FURTHER RESOLVED, that the Alabama Republican Executive Committee urges each member of the Alabama Congressional Delegation to H.R.204, American co-sponsor the Sovereignty Restoration Status: Act. **PASSED** 

RESOLUTION NO 2021-02, RESOLUTION URGING THE RESCINDING OF ALL ARTICLE V CONVENTION APPLICATIONS

NOW THEREFORE, BE IT RESOLVED by the Alabama Republican Executive Committee that the Legislature of the State of Alabama be requested to rescind all applications by the Legislature of the State of Alabama to the Congress of the United States of America to call a convention to propose amendments to the Constitution of the United States of America pursuant to Article V thereof; and

BE IT FURTHER RESOLVED, that the Alabama Republican Executive Committee urges each member of the Alabama Legislature to oppose any and all other or additional applications to Congress of the United States of America to call a convention to propose amendments to the Constitution of the Unites States of America pursuant to the terms of Article V thereof; and

BE IT FURTHER RESOLVED, that a copy of this resolution be transmitted to each member of the Legislature of the State of Alabama, Status: PASSED Here I would like to add some background information about this particular resolution. I was personally contacted by Mr. Wayne Christopher back in January 2019. Mr. Christopher asked me to support passing a CCREC resolution requesting that the Alabama legislature rescind its previous calls for an Article V convention to amend the U.S. Constitution. I thought it was unusual for a stranger to call and make such a request, so I did some research.

A quick internet search revealed that much of the literature that Mr. Christopher had sent to me directly reflected the positions of the John Birch Society. As I read more articles at the JBS website that warned about the dangers of an Article V convention, I discovered that their primary concern is that such a convention could turn into a "runaway" convention that could pass and enforce amendments to the Constitution without following the proper ratification process. Here is a JBS video that explains their concern.

Of course, we all should know that the U.S. Constitution, amendments to whether proposed by Congress or an Article V convention of states, require ratification by 3/4 of states to become part of the Constitution. The JBS insists that a convention could "runaway" though, and they use the example of the convention in Philadelphia in 1787, where delegates met to amend the Articles of Confederation, but instead wrote a totally new Constitution. This is a silly argument because the delegates in 1787 weren't meeting under the authority of the U.S. Constitution, but instead the Articles of Confederation. Further, the new Constitution required ratification by 2/3 of states, and did

not claim to have any authority over states that refused to ratify. Of course, we know that all 13 original states did ratify the new Constitution. The 1787 convention was in no way an example of a "runaway" convention.

I didn't know much about the JBS, but did some reading and found that they were also proponents of the U.S. withdrawing from the United Nations, which corresponds also with RESOLUTION NO 2021-01. Considering this along with the efforts like Mr. Christopher's request for a CCREC resolution, it becomes obvious that members of the JBS are quite active in pushing their agenda items in the Alabama Republican Party. This fact alone may not necessarily be a big problem, but their reluctance to identify themselves as JBS members and the JBS's history of controversial conspiracy theory positions bears careful watching.

RESOLUTION NO 2021-03, RESOLUTION CALLING FOR PUBLICATION OF COST EFFECTIVENESS STUDY OF INVESTMENTS BY ALABAMA'S PUBLIC UNIVERSITIES IN DIVERSITY AND INCLUSION PROGRAMS

NOW THEREFORE BE IT RESOLVED that the Alabama Republican Party calls on the Alabama Commission on Higher Education and on the individual university boards oftrustees to conduct and publish a "cost versus benefits" analyses justifying budget requests for the funding of planned Diversity and Inclusion expenditures.

RESOLVED FURTHER that a copy of this resolution, once adopted, be transmitted to the Governor of the State of Alabama, the Lieutenant Governor, the Speaker of the House, the Chairman of the Alabama

Commission on Higher Education and to the president of every public college and university within the State of Alabama. Status: PASSED

RESOLUTION NO 2021-04

RESOLUTION CALLING FOR REMOVAL OF CONGRESSWOMAN LIZ CHENEY AS HOUSE REPUBLICAN CONFERENCE CHAIR

NOW THEREFORE, BE IT RESOLVED by the Alabama Republican Executive Committee that we urge each and every State Republican Executive Committee and the Republican members of the Alabama Delegation in Washington, DC to continue to seek the immediate removal of Congresswoman Liz Cheney as House Republican Conference Chair.

RESOLVED FURTHER that a copy of this resolution, once adopted, be sent to each State's Republican Executive Committee and to each Republican member of the Alabama Delegation in Washington, DC. Status: PASSED

RESOLUTION 2021-06, RESOLUTION URGING SUPPORT OF KEEP NINE AMENDMENT

NOW THEREFORE, BE IT RESOLVED that the Alabama Republican Executive Committee hereby petitions the Alabama Legislature to obtain clarification on the use of Hydroxychloroquine, as was done recently by the Texas Medical Board, in order to give the citizens of Alabama the right to decide, together with their physicians, on outpatient treatment of COVID-19 infections with the HCO cocktail. Status: PASSED

Note: An executive Committee member identifying himself as a physician spoke against this resolution. The member claimed that there are currently no impediments preventing doctors in Alabama from prescribing hydroxychloroquine for their patients. It was my opinion that this resolution was not necessary, and I voted against it.
