# **Memorial Day Thoughts from Chairman Huguley**

We all have stories and memories from Memorial Day. I know with busy schedules and day to day tasks it is easy to sometimes forget to reflect on the true meaning of a holiday. I wanted to take a moment and put a few of my thoughts down when I reflect on Memorial Day.

The American Civil War ended during the Spring of 1865. It is estimated that around 620,000 Union and Confederate soldiers died between 1861-1865. By the late 1860's many towns and cities had begun honoring the fallen soldiers, which became known as Decoration Day, and as time passed evolved into being called Memorial Day. In 1968 Congress passed the Uniform Monday Holiday Act that would officially designate the last Monday of May, beginning in 1971, as Memorial Day. As a nation we observe Memorial Day as a way to honor our military

heroes who have paid the ultimate sacrifice defending our country and freedoms.

Probably like many of you, I have had the privilege to visit Arlington National Cemetery, and in my opinion, it is one of the most sacred pieces of ground in America. It is difficult for me to describe the feeling of standing at the Tomb of the Unknown Soldier while the 3rd U.S. Infantry Regiment (the "Old Guard") stands watch 24 hours a day 7 days a week 365 days a year. Or standing on the hill at Arlington House overlooking some of the over 400,000 veterans buried there. Arlington brings so many emotions and thoughts to mind such as pride, patriotism, heroism, duty, sacrifice, service, etc. Each gravesite has an individual story to tell that has contributed in building and protecting our great country. On Memorial Day, in a particular part of the cemetery, the "Old Guard" will place 228,000 small American flags by the headstones of the fallen.

As we approach Monday, May 29th, 2023, I encourage everyone to take a moment and reflect on the sacrifices that have been made by so many that allow us to enjoy the freedoms and prosperity that we have. Freedom is absolutely not free. I'll close with the following quote by President Ronald Reagan from a speech he made at Arlington National Cemetery on Memorial Day in 1982

"Yet, we must try to honor them—not for their sakes alone, but for our own. And if words cannot repay the debt we owe these men, surely with our actions we must strive to keep faith with them and with the vision that led them to battle and to final sacrifice."
